A LETTER FROM THE CHAIR

We had a great year despite the lingering setbacks imposed by the Covid pandemic: everyone's resilience has been truly inspiring. A theme that characterizes the work done in the department in 2022 is connection and community building. The work highlighted in this Newsletter reveals a community dedicated to care, academic excellence, and to bridge building.

In February, Loyola's Johanna Oksala presented a timely discussion on the existential impact of global warming ("Climate Change as an Existential Threat: Environmental Politics in the Shadows of Nihilism"). Our Graduate Student Conference, "Perspectives on Carcerality, Surveillance, Policing, and Abolition," was also held in February and featured the work of our own Kevin Thompson and Perry Zurn (who now is an Assistant Professor at American University), who recently co-edited, Intolerable: Writings from Michel Foucault and the Prisons Information Group (1970–1980). In April, Sayak Valencia gave our first ever talk in Spanish (with simultaneous translation thanks to the efforts of our graduate students), "Gore Capitalism, Necromasculinities, and Transfeminisms."

In March, we hosted a meeting of the Chicago-Area Consortium in German Philosophy, "The Hermeneutics of Suspicion Revisited" – with talks by our own Elizabeth Rottenberg (who played with the notions of 'wit' and 'witz' as she presented Freud's work) and Jennifer Gammage (who commented on Jackie Scott's paper).

April brought us an excellent talk on comparative philosophy by Rohan Sikri (University of Georgia), this year's Pleshette DeArmitt Memorial speaker.

In May we hosted a meeting of the North American Fichte Society on Fichte's practical philosophy, and Prof. Emeritus David Krell visited us, presenting "Philosophy and Anecdote" in his characteristically engaging way— he also gave a presentation to the Philosophy Circle, "Philosophy and Language Learning" for our undergraduates.

In addition to the many visiting speakers we had over the last months, we are fortunate to have Valentina Moro as a visiting scholar. Valentina is an Assistant Professor in political philosophy at the University of Verona in Italy. Her research stay at DePaul is funded by the Marie Sklodowska-Curie Global Fellowship.

In May, nine pairs of undergraduate and graduate students, who had been awarded DUOS Fellowships, presented their research at our annual DUOS Conference. In 2007, we launched the DUOS (Doctoral and Undergraduate Opportunities for Scholarship) program, to enhance the collaborations between our undergraduate and graduate students.

DUOS provides funding for a research project that is conducted by an undergraduate and graduate student, with a faculty mentor advising the project. The DUOS program is generously supported by the Dean's Office and the Maimonides Endowment in Philosophy. The presentations made clear that giving undergraduate students the opportunity to work with graduate students not only helps prepare the undergraduate for more advanced scholarship, but also helps bolster the scholarship of our graduate students and strengthens their mentoring skills.

In June, we celebrated the work of our graduating majors with a dinner at our new gathering place, El Presidente. In the photos you will see Erik Zamora next to Peg Birmingham: at the dinner Erik recounted that Peg's philosophy of law course was transformative for him. Erik will begin law school at University of Colorado, Boulder this fall. Another one of our majors, Rugile Kasperiunaite, is headed to the Ph.D. program in philosophy at the University of Oregon, with a full fellowship. Congratulations, Erik and Rugile! We look forward to hearing about all the great work you will do.

In June our own outstanding student assistant, Jeannine Garland, was honored at the Wicklander Symposium for her incredible assistance to Prof. Daryl Koehn at the Institute for Business and Professional Ethics – congratulations, Jeannine, and thank you for all your generous service to us!

Several of our graduate students are now leaving us to begin the next chapter of their careers. We had a record 9 successful dissertation defenses this academic year! Congratulations to Drs. Vilde Aavitsland, Evan Edwards, Ryan Froese, Owen Glyn-Williams, Tom Krell, David Maruzzella Michael Peterson, Rachel Silverbloom, and Paul Turner! One of our recent Ph.Ds., Zhen Liang, has accepted a position of Visiting Assistant Professor at Oxford College at Emory. Rachel Silverbloom will be at Vassar College with a Mellon Postdoc Fellowship in Feminist Philosophy. Vilde Aavitsland and Ryan Froese have accepted offers at University of Louisville. We wish them all the best -- we will certainly miss their presence here in Chicago.

In June, we said goodbye to Amaury Carol and Nassim Khiter, our ENS Exchange students this year. We benefitted from their contributions to our program throughout the year. We wish them all the best as they return to their studies in France. We look forward to welcoming back Evan Edwards Evan O'Donnell, who spent the last year in Paris as our ENS Exchange Student.

ELIZABETH MILLÁN co-organized, with Avery Goldman, the Fifteenth Biennial Meeting of the North American Fichte Society this past spring, held on DePaul's Lincoln Park campus from May 19-21. Pictured left, she traveled to Stockholm to present the paper,"The Arts of Science and the Science of Art: Humboldt and Goethe on the Beauties of Nature," at the Annual Conference of the Society for German Idealism and Romanticism, Aesthetics and Idealism in the Age of Goethe at Södertörn University in early June.



In the last two quarters, **RAFAEL VIZCAINO** published two peer-reviewed articles: one on the concept of fetishism in Latin American philosophy, and another on the transdisciplinary character of Sylvia Wynter's work. He also celebrated the long-awaited publication of Lápiz no. 7 (the journal of the Latin American Philosophy of Education Society [LAPES]), which gathers selected contributions from the 2020 LAPES symposium that Rafael hosted virtually in the fall of 2020 as a collaboration between Rutgers University and DePaul. This celebration concluded in a hybrid workshop at Columbia University (NYC), where Rafael discussed the importance of developing a decolonial critique of modern secularism alongside the renowned radical theologian and activist-scholar Mark Lewis Taylor (Princeton Seminary). At the 2022 APA Central Division Meeting (sponsored by the Society for Mexican American Philosophy), Rafael presented a paper on the spirituality of violence as it pertains to the phenomenon of narco-violence in Mexico. Lastly, over an intense period of two days in the month of April, he co-curated and co-moderated three 3hour seminars on the topic of "Beyond Secularization" at the 3rd Political Theology Network Conference, which took place at the Center for the Study of Religion and Conflict at Arizona State University.



FANNY SÖDERBÄCK received the DePaul Humanities Center Fellowship for the next two years for her project, "Vulnerability and Singularity in Pandemic Times," related to her work on a forthcoming monograph on Adriana's Cavarero's philosophy of singularity.



PETER STEEVES was selected by President A. Gabriel Esteban as a 2022 recipient of the Via Sapientiae Award for his distinctive service to the DePaul community. This award is the highest honor DePaul bestows, and will be conferred to Peter during Academic Convocation on September 1, 2022.

Peter's art installation, "Bry'n Lambert, Realtor." was included in the Installation Art Exhibition, "Un Jetzt?!" He created audio, video, and material objects for an installation that recreated the office of a realtor who is obsessed with the relation between "realtor" and "reality."

Peter also presented a series of talks over the past winter and spring quarters: the first being "Sustainability as a Form of Empire," at the Eighteenth International Conference on Environmental, Cultural, Economic & Social Sustainability in Granada, Spain. Peter presented his talk online. In April, he presented, "Defund the Jedi: An Anarchic Reading of Star Wars," at the Popular Culture Association's annual meeting, online, in April 2022. Finally, he presented, "The End of Metaphysics," an invited lecture in Christopher Lauer's online metaphysics course, for the Department of Philosophy at the University of Hawai'i at Hilo, May 2022.



DARYL KOEHN presented two talks at the July 2022
International Society for Business Ethics and
Economics held in Bilbao Spain. The first talk
centered on why progress in not being made toward
attaining the United Nations Sustainable
Development Goals; her second talk was entitled
"Using the OCAI Framework to Evaluate Ethical
Challenges in Particular Types of Corporate
Cultures." She will present another paper "Who Gets
Conned and Why? Toward a New Narrative Approach"
on August 5, 2022 in Seattle, Washington at the
Society for Business Ethics Annual Meeting.



PEG BIRMINGHAM attended the "Reconciliation as a form of *Gelassenheit*: Thinking Arendt and Schürmann on the Double Bind of Principle and Origin," conference, held in Stockholm, Sweden, in June 2022.



KEVIN THOMPSON presented three talks throughout the past two quarters. The first, "Hegel's Hermeneutical Critique and the Problems of Poverty," was given at the Third Biennial Conference of the Australian Hegel Society, held online. Sean was chosen to give the Keynote Address at the Texas A&M Annual Graduate Student Conference, presenting "Nietzsche and Tragic Philosophizing," held in College Station, TX, in April 2022.

Sean also held a "Philosophical Career Workshop," with the Texas A&M Doctoral Students on April 15th.



VILDE LID AAVITSLAND recently accepted a position as Visiting Assistant Professor at the University of Louisville, starting on August 1, 2022.

Additionally, her paper, "The 'Politics of Ourselves' as a Politics of Conditions: A Political Reading of Self-Transformation in Foucault," was chosen as Honorable Mention for "Best Submission by a Graduate Student" by the Society for Phenomenology and Existentialist Philosophy. The paper will be presented at the 60th meeting of the SPEP in October, with a commentary by Professor Verena Erlenbusch-Anderson of Syracuse University.



JENNIFER GAMMAGE recently organized and chaired "Philosophers working Carceral Contexts," an APA Live webinat this past June. The webinar is <u>available to stream</u> for all APA members on the APA On Demand site.

Jen contributed a blurb on the importance of building mutual aid networks to "Cities After COVID" in *The Philosopher's Magazine*, with the publication forthcoming. She is also working to organize a summer fundraiser for Rogers Park Food Not Bombs, an autonomous collective that offers weekly free food and refreshment distribution in Rogers Park and works to support our unhoused community members with emergent needs.

In the future, Jen will be presenting "Anzaldúa's Pluritopic Hermeneutics" at the Canadian Society for Women in Philosophy Conference on "Aftermath" at Oakland University. The event will take place this upcoming October.

She will also be publishing her work, "Overcoming Nihilism and Dehumanization: Nietzsche, Anzaldúa, and Self-Historicizing," in Routledge Handbook of Contemporary Existentialism, edited by Kevin Aho, Megan Altman, and Hans Pederson (New York: Routledge), coming out in Spring 2023.

She is writing the "Uncanny as a Concept in Phenomenology" entry for the Springer Encyclopedia of Phenomenology, edited by Ted Toadvine and Nicolas de Warre, forthcoming Winter 2023.



DAN PERLMAN attended the 2022 meeting of the Foucault Circle, which took place from May 13th-15th at Emory University in Atlanta, Georgia. There he presented his paper, "Posthuman Power and the Historicity of Matter," which engages with Beatrice Han's critique of Foucault through the more recent work of Karen Barad.



HECTOR RAMOS RAMOS was awarded the Hank Center Fellowship, given yearly to graduate students working on topics in the Catholic Intellectual Tradition. The fellowships encourage and support graduate students in their exploration of the Catholic intellectual tradition in its many disciplinary and creative forms—in theology and philosophy, literature and the arts, natural and social sciences, social movements and culture, pedagogy and pastoral life.

VILDE LID AAVITSLAND

Vilde successfully defended her dissertation, "Conditioned by History: Experience and Critique in Foucault's Thought," on January 21, 2022.



"Vilde's dissertation offered a rigorous and subtle investigation of what it means to say that we are conditioned by our histories. She developed a thorough exploration of the work of Michel Foucault to address this question and the committee agreed that the thesis was a tremendous success and her defense of it was nothing short of being a model of what a defense should be."

MICHAEL PETERSON

Michael successfully defended his dissertation,"Half-Lives of Responsibility: Gramsci, Derrida, and Inheritance in Environmental Ethics," on February 25th, 2022.



"Michael Peterson defended on February 25, 2022 a dissertation that could not be more important or more timely on the themes of time, language, responsibility, and inheritance in relation to contemporary problems of climate change, environmental instability, and, especially, the pernicious and unique problems posed by nuclear waste. Titled "Half-Lives of Responsibility: Gramsci, Derrida, and Inheritance in Environmental Ethics," this dissertation is a rigorous academic work, a genuine work of scholarship, but it is also something like a plea or a call to all of us to heed these extremely pressing, even dire, issues for both ourselves and the generations that will come after us." EVAN EDWARDS

Evan successfully defended his dissertation, "Autotrophy of the Other: On Food and Hospitality," on May 27th, 2022, via Zoom.



"Evan Edwards' dissertation was ostensibly on the topic of food and hospitality. In the end, it not only brought new insights to these two areas of inquiry but also raised such important questions as what sort of text a recipe is, what it means to be a self that can taste, what it means to be edible as well as to eat, the ethics/politics of the restaurant industry, and whether or not ethics is even possible in a universe where all life is predicated on needing other beings to die. Ultimately, Evan's work is a deep, poetic, thoughtful rumination on vegetal life—and on life in general. Beautifully written and eloquently argued, the dissertation was unanimously found to be worthy of being passed with distinction by the members of Evan's committee. "

RACHEL SILVERBLOOM

Rachel successfully defended her dissertation, "Nonlinearity as Care: Black, Feminist, and Queer Temporalities of History," on Friday, June 10th.



"Dr. Silverbloom examines the intimate links between the linear-progressive conception of history that dominates our political and philosophical context, and anti-Black violence in the wake of slavery. She argues that non-linear forms of time, memory, and history offer more generative frameworks for thinking practices of care and relationality, and for challenging the ideology of white supremacy. One of the most impressive aspects of her project is the manner in which it brings together diverse bodies of work, from philosophy to critical race theory, from feminisms of color to queer studies, and from art and literature to television and music. She does this seamlessly, and through a series of reflections on time, history, memory, and memorialization. She draws concepts from these bodies of work – temporal drag, sweeping, mood, time signatures, wake work – to offer a multifaceted yet systematic account of how non-linear modes of time can help us activate the past such that we can better understand the ongoing ways in which it shapes our present and future."

"Tom's dissertation was a masterful analysis of the largely unexplored relationship between two figures: Jacobi and Hegel. Tom argued that Hegel's *Science of Logic*, especially the Logic of Essence and that of the Concept, should be read, surprisingly, as a thorough–going realism, a philosophy of immediacy, a proof of axiological content. All of this, he demonstrated, in response to the threat that Jacobi articulated around the problem of nihilism and the nature of rationality. The committee agreed that the thesis was exceptionally well defended and deserving of the mark of 'passed with distinction'."


Owen successfully defended his dissertation, "Civil War and the Government of Factions in Hobbes and Foucault," on April 1st, 2022.

Philosophy Today welcomes Gregory Convertito as the new assistant editor of the journal, joining Will Cox. Welcome, Greg!




