I. Doctoral Funding Resources

- American Association of University Women (AAUW) Dissertation Fellowships support women scholars who are pursuing full-time study to complete dissertations. The purpose of the American Dissertation Fellowship is to offset a scholar's living expenses while they complete their dissertation. - American Council of Learned Societies Fellowship Program invites research proposals from scholars in all disciplines of the humanities and related social sciences. The ultimate goal of the project should be a major piece of scholarly work by the applicant, which can take the form of a monograph, articles, digital research project, critical edition, or other scholarly resources. The fellowships support projects at any stage of development. This program does not fund works of fiction (e.g., novels or films), textbooks, straightforward translation, or pedagogical projects. ACLS Fellowships are intended to help scholars devote six to twelve continuous months to full-time research and writing.

- Mellon/ACLS Dissertation Innovation Fellowships provides a year of support for doctoral students preparing to embark on innovative dissertation research projects. The fellowship may be carried out in residence at the fellow's home institution or at any other appropriate site for the research. • Berlin Program for Advanced German and European Studies

The Berlin Program for Advanced German and European Studies offers up to one year of research support at the Freie Universität Berlin. It is open to scholars in all social science and humanities disciplines, including historians working on the period since the mid-19th century. The program accepts applications from U.S. and Canadian citizens, permanent or long-term residents. - **Bourse Chateaubriand Fellowship** is a grant offered by the Embassy of France in the United States. It supports outstanding PhD students from U.S. institutions who wish to conduct part of their doctoral research in France for a period ranging from 4 to 8/9 months. • Fulbright Grants

The <u>Fulbright-Hays Doctoral Dissertation Research Abroad Program</u> awards grants to individual U.S. K-14 pre-teachers, teachers and administrators, pre-doctoral students and postdoctoral faculty, as well as to U.S. institutions and organizations

The <u>Fulbright Visiting Scholar Program</u> provides grants to approximately 900 foreign scholars from over 100 countries to conduct post-doctoral research at U.S. institutions from an academic semester to a full academic year.

<u>Fulbright Teacher Exchanges</u> provide opportunities for U.S. and international primary and secondary educators to develop their educational practice and bring international knowledge, skills and perspectives to their classrooms and schools.

• The Harry Frank Guggenheim Emerging Scholar Awards (formerly the Harry Frank Guggenheim Dissertation Fellowships) recognize promising graduate-student researchers in their final year of writing a doctoral dissertation examining a salient aspect of violence. The Foundation welcomes proposals from any of the natural and social sciences or allied disciplines that promise to increase understanding of the causes, manifestations, and control of violence and aggression. • Jacob K. Javits Fellowships Program

This program provides fellowships to students of superior academic ability—selected on the basis of demonstrated achievement, financial need, and exceptional promise—to undertake study at the doctoral and Master of Fine Arts level in selected fields of arts, humanities, and social sciences. Eligibility is limited to individuals who at the time of application-- (1) will be entering a doctoral program in academic year and/or who, at the time of application, have not yet completed their first full year of study in the doctoral program for which they are seeking support; (2) will be entering a Master of Fine Arts program where the master's is the terminal highest degree awarded in the selected field of study.

• The Mitchem Dissertation Fellowship Program is intended to increase the presence of underrepresented ethnic groups by supporting doctoral candidates in completing their final academic requirement, the dissertation. The fellowship provides a student from other U.S. universities with one year of financial support, including a stipend, fringe benefits, and research and travel funds. The fellow will be in residence at Marquette for an academic year, during which recipient will teach one course in their area of specialization while completing their dissertation.
