COVID-19 and Student Life

COVID-19 has impacted universities across the U.S. in a variety of ways. How have students at DePaul been impacted directly?

-Faculty Council has recommended and Provost Ghanem has approved a resolution allowing students the option to adopt a Pass/D/Fail (P/D/F) grading basis in Spring and Summer 2020 courses. By the last day of classes in Spring Quarter and in each Summer session, students will be able to declare their decision to move from the traditional A to F grading basis to the P/D/F basis.

-The CARES Act includes a Higher Education Emergency Relief Fund. The fund provides \$7.1 million to help DePaul students for expenses related to the disruption of campus operations due to COVID-19. According to the Department of Education, students who have completed a FAFSA, are Title IV aid eligible and were enrolled in what were intended to be face-to-face classes when DePaul closed its campus on March 13, 2020, are eligible to apply. Eligible students will receive a grant of \$500. Applications will be considered until June 15.
